### **James McNitt, Southern AgCenter Professor of Animal Science**

“Pasture Rearing of Poultry and Rabbits”, November 10, 2005

**Interests:** For many years, he has carried out research on production systems for meat rabbits and, within the past 8 years, has expanded his work to include pastured poultry. In addition to many publications in scientific journals, he has produced numerous fact sheets and other informational materials for producers. He is currently developing a pasturing system for rabbits as well as participating in a research program to evaluate the effects of pasturing on the meat of rabbits and the meat and eggs of chickens.

### **Fatemeh Malekian, Southern AgCenter Associate Professor of Nutrition**

**Interests:** She is Principal Investigator (PI) for Dietary Assessment and Intervention for Katrina Victims Settled in Baker, Louisiana project and Co-PI in the Pasture Rearing of Chicken and Rabbit project. She has published a number of scientific publications, and produced fact sheets and other informational materials.
