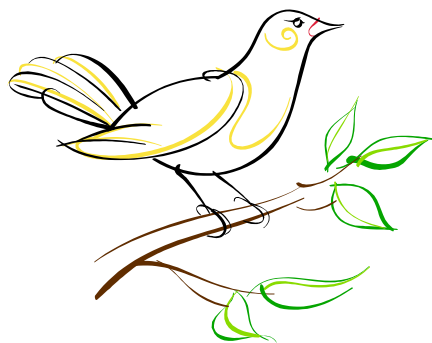

**Executive Committee Meeting**

**Attending:** Aubrey Mendonca, Mark Love, Kristen Robbins, Bob Bahn, Joan Randall, Rachel Ollinger, Chiew-Ling Chia and Janis Hochstetler.

1. Meeting called to order at 3:45 pm by Robbins at Jasper Winery.
2. Secretaries Minutes from September 15, 2005 meeting were reviewed. Love moved and seconded by Mendonca to approve the secretaries minutes. Motion passed.

Additionally, Hochstetler asked that at registration those who do not have a pre-made name tag or need a replacement name tag please fill out the “name-tag sheet” so that new name tags are made.

Hochstetler reported that the website has been updated and if anyone needs to post something to please forward it to her. Hochstetler also had the most current membership list for review- especially email addresses.

3. Wang (treasurer) was not in attendance. There was a question about the bill from the Machine Shed for the September meeting meals. There was a charge added for the bar that was not anticipated. Wang was looking into this. There would be two speaker meals to sponsor for the November meeting.
