AN EVENING IN THE IOWA “NAPA VALLEY”

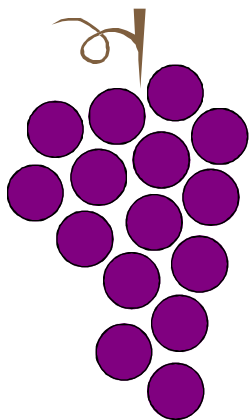

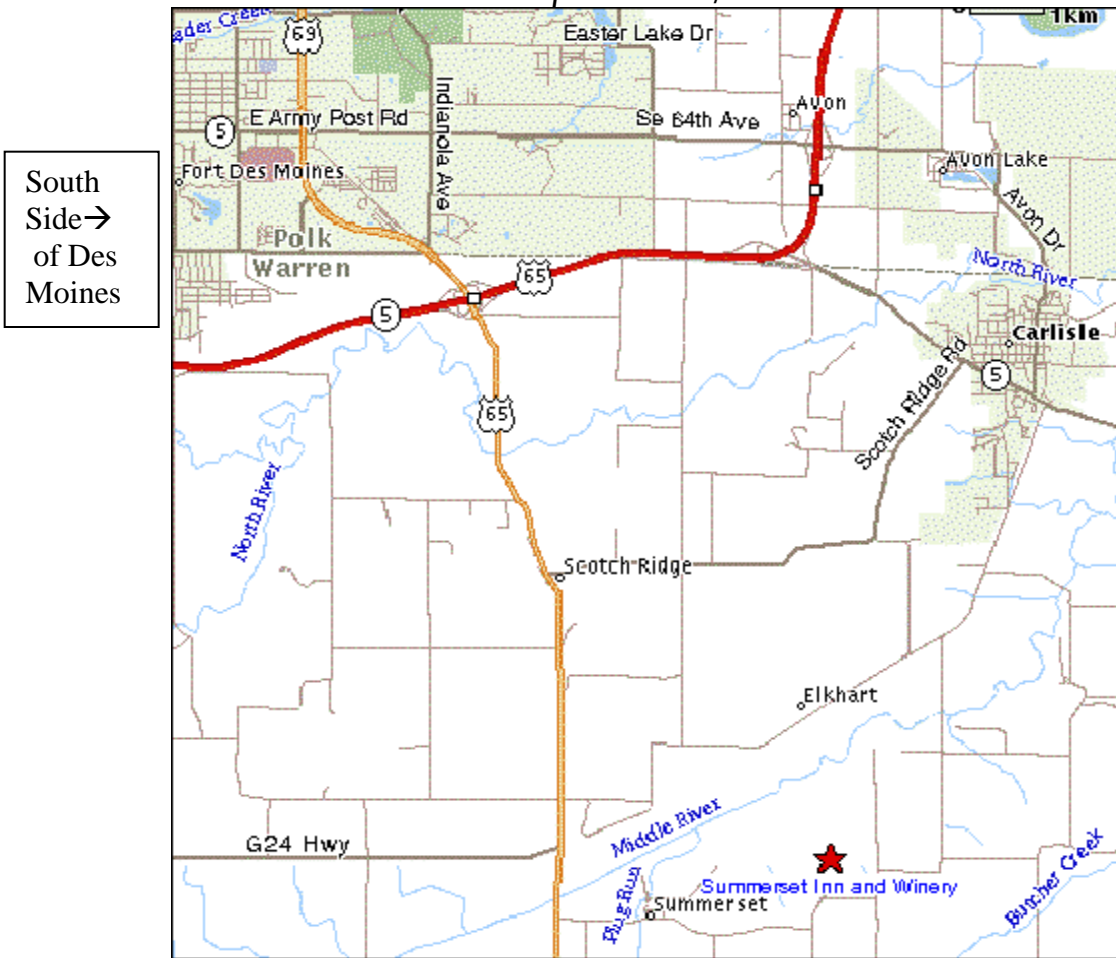

Executive Committee Meeting

Attending: Tony Pometto, Dave Raife, Lester Wilson, Tonya Armstrong, Cheryl Reitmeier, Janis Hochstetler, Linda Svendsen, Theresa Walters

1. Wilson moved acceptance of the minutes, Hochstetler seconded. Motion passed.
2. Reitmeier reported that secretarial support would include sending meeting announcements via e-mail and the Iowa-section website. Some members need meeting announcements mailed to them. Some newsletter information could be available in paper form at meetings. Dues for Iowa-IFT membership are \$12/year. Sherri Angstrom (secretarial support) will be trained about updating the website. Sherri will be paid through the FSHN Dept; Iowa-section will pay FSHN.
3. Raife gave the Treasurer's Report; balance \$10,934.75. He voiced some concerns that no financial support had been received from Iowa industry for the scholarship funds. Janis suggested discussing this issue at the summer executive committee meeting. Dave has sent letters to companies in Iowa. Armstrong suggested e-mail messages.

4. Committee Reports

- a) Scholarships and Awards: Hochstetler reported that there were 5 applicants for undergraduate scholarships (\$500) and no graduate student applications. There was one applicant for the Iowa Industry scholarship and 2 nominations for the Outstanding IFT Member award.
- b) Nominations: Wilson presented nominations for 2003-4 officers. Mark Love, Chair-elect, Linda Svendsen, Councilor, Terri Boylston, Alternate Councilor, Elaine Wolf, Member-at-large, Janis Hochstetler, Member-at-large. Secretary and MFPC representative positions are still needed.
- c) Students: Theresa Walters reported about student activities at Veishea, College Bowl team, sale of T-shirts, participation in the IFT Chapter of the Year competition, product development and representatives for next year. They requested some financial support to attend IFT for participation in the College Bowl competition. Expenses were estimated to be \$2000; IFT will provide \$1000. Armstrong moved to support the students with \$1500, Wilson seconded, motion passed. Student representative for 2003-4 is Natalie Weinsedel.

Toshiba Traynham reported that she and Dave Stevenson worked on increasing IFT visibility and student participation during the year by informing students of upcoming meetings, events and scholarships via e-mail, FSHN 580 presentation, Food Science Club meetings, and collection of dinner fees from students prior to meetings. Student participation has increased because of their efforts. Traynham suggested a planned social hour for students to increase interaction between students and members, a Food Science Jeopardy or Quiz Bowl for all members, or a formal question & answer period for increased contact between students and professional members.

- d) Midwest Food Processing Conference: Wilson reported that MFPC will be held in Chicago in 2003 with Wisconsin as host. The focus of the conference is food processing and Larry Johnson, CCUR at ISU, will participate. Bob Olson is the Iowa representative. Iowa will be the host of MFPC in 2004.
- e) 2004 Suppliers Night: Raife volunteered to chair the committee. The location was discussed. Turn-out needs to increase. Would Des Moines be a better location?

5. New Business

Executive meeting for summer was discussed. It is usually held before IFT at the Fireside Inn in Toledo, IA. Svendsen will attend IFT as the Iowa Councilor. Pometto will send a letter to IFT about the substitution and Armstrong will send the information to Linda. Joe Sebranek would like to be nominated for the IFT Executive Committee.

Adjourned at 6:15 pm

Reservations for dinner meetings of the Iowa Section IFT are to be mailed or faxed to the person indicated on the reservation form by the date indicated on the reservation form. For prepaid reservations, please be sure to mail the check early enough so that it is received before the day of the meeting. All checks should be made payable to the Iowa Section IFT. Persons with dinner reservations that are not prepaid before the day of the meeting will be charged \$5 more at the door.

Students who are members of the Iowa Section IFT can make prepaid reservations at a cost of \$10 per meal. Students who have not preregistered and prepaid will pay \$15 at the door. The Iowa Section IFT subsidizes student dinners at each meeting to encourage involvement of students in IFT activities. Students can join Iowa Section IFT for \$2. Students who are not Iowa Section IFT members and who do not have prepaid reservation must pay the same as the member rate at the door.

Reservations cancellations should be made as early as possible. Prepaid reservations that were cancelled by the late date indicated for meeting registration will be cheerfully refunded. If a cancellation is not made another person from the same company or someone who is otherwise designated *and who does not have a reservation*, may use the reservation. WE cannot refund for reservation that are cancelled after that date because we have already given a firm plate count to the restaurant and we will be charged for that number of meals whether or not they are eaten.

If you have special dietary concerns regarding the meal to be served at one of our meetings, please indicate this when you make your prepaid reservation. Please indicate your dietary restriction (vegetarian, etc.) with your name and telephone number so that you can be contacted about possible alternatives. All reservation for meals that indicated special concerns must be prepaid because we must make special arrangements for alternatives with the restaurant.
